#### INTRODUCTORY REMARKS

Jim Cloos is presently Secretary General of TEPSA. Before his retirement in 2021 he was Director-General in the General Secretariat of the Council of the European Union, where he oversaw teams dealing with the preparation of European Council meetings, co-legislation, inter-institutional relations, and support to the rotating Presidency. Jim Cloos started his career as a Luxembourg diplomat. After moving to the European Commission, he headed the Cabinet of the Commissioner in charge of agriculture between 1993 and 1995 and was Head of Cabinet to the President between 1995 and 1999. Between 2001 and 2006, he was Director for relations with the US in the Council Secretariat and a close collaborator of the High Representative Javier Solana.

Hans Wallmark is the Chairman of the Committee on European Union Affairs since 2022. He is a member of the Moderate Party and has been a member of the Swedish Parliament since 2006. Hans Wallmark served as President of the Nordic Council in 2014 and in 2019. He has been a member of the Defence Committee and the Foreign Policy Committee of the Parliament as well as the spokesman for the Moderates on defence issues.

### WAR IN EUROPE - CONFRONTING NEW REALITIES

Jan Knutsson is State Secretary for Foreign Affairs, assuming office in 2022. Prior to that he was Ambassador of Sweden to Switzerland and to the Principality of Liechtenstein. Between 2016 and 2019, Mr. Knutsson was Ambassador of Sweden to the Kingdom of Saudi Arabia, as well as non-resident Ambassador to the Sultanate of Oman and Republic of Yemen. Between 2015-2016, he was Ambassador and Coordinator for Migration and Refugee Issues at the Ministry for Foreign Affairs in Stockholm. Before that, Mr. Knutsson was the Permanent Representative of Sweden to the United Nations and other International Organizations in Geneva between 2010-2015, and Director General for International Development Cooperation at the Swedish Ministry for Foreign Affairs between 2006 and 2010.

Simone Bunse (PhD) is the Content Manager of the Stockholm Forum on Peace and Development, Researcher at the Stockholm International Peace Research Institute (SIPRI) and Senior Fellow at LEAD University. Previously she was Director of Academic Affairs at LEAD University; Associate Professor at Georgetown University; Assistant Professor at INCAE Business School; and Visiting Researcher at the Free University of Brussels. Her book Small States and EU Governance - Leadership through the Council Presidency won the Choice Outstanding Academic Titles Award by the American Library Association for excellence in scholarship. Her most recent work is focusing on advancing European Union Action to Address Climate-Related Security Risks.

# ESTABLISHING AN EFFECTIVE, HUMANITARIAN AND SAFE MIGRATION POLICY FOR EUROPE

Pawel Busiakiewicz is Head of Unit for International Affairs at DG HOME. He graduated in Law at the Wroclaw University (Poland) and pursued postgraduate studies in European Law at the R. Schuman University (Strasbourg) and College of Europe (Brugge).
